REGISTRATION FEE INFORMATION

- ◆ Registration Fee is due upon entry and each year thereafter in March / April.
- ◆ Registration Fee is non-refundable.
- ◆ Registration Fee includes: office records, student accident insurance, consumable supplies, and ACSI membership.
- ◆ If a deposit was paid to be placed on a waiting list, the deposit will be applied to the Registration Fee.

TUITION ACCOUNT INFORMATION

- ◆ Tuition fees are effective June 13, 2011.
- ◆ When establishing multi-child tuitions, your oldest child is the “first child” in our system with the exception of an infant in infant care, in which case the infant is considered the “first child.”
- ◆ No additional discounts are available, other than those documented on the reverse side.
- ◆ Tuition is a weekly fee.
- ◆ **ALL PAYMENTS** are due on Mondays (tuition, late fees, etc.). Accounts with any outstanding balance after 12:00 PM on Wednesdays will be assessed a late fee of \$20.00, due on the following Monday.
- ◆ Accounts that are not kept current may result in the child being removed from our program.
- ◆ Cash, checks, or money orders will be accepted in the school office. Do not leave cash with teachers.
- ◆ A service charge of \$40.00 will be assessed for each NSF check that is issued to the school. All checks physically returned to us by the bank have had two attempts made to be cleared, thus resulting in a total of \$40.00 in fees. After two returned checks, only cash, money order, or charge will be accepted for future payments.
- ◆ We accept Visa, MasterCard, and Discover. A \$7.00 convenience fee applies per transaction.
- ◆ Receipts for tuition payments are available upon request.
- ◆ Tuition can be paid up to 4 weeks at a time, in advance.
- ◆ Upon enrollment, first and last weeks’ tuition is due and is non-refundable.
- ◆ The last weeks’ tuition will be applied with 2-weeks written notice of withdrawal.
- ◆ A fine of \$1.00 per minute for late pick-up after 6:30 PM will be assessed and due with the next tuition payment.
